Vision And Mission

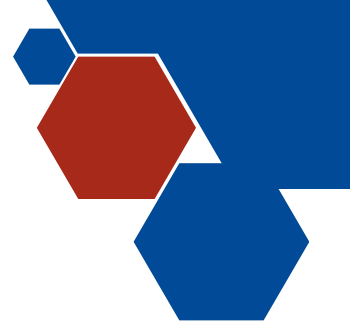
Vision

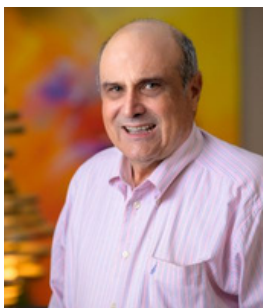

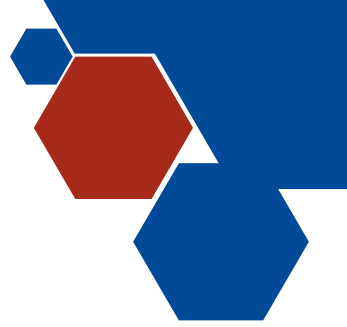

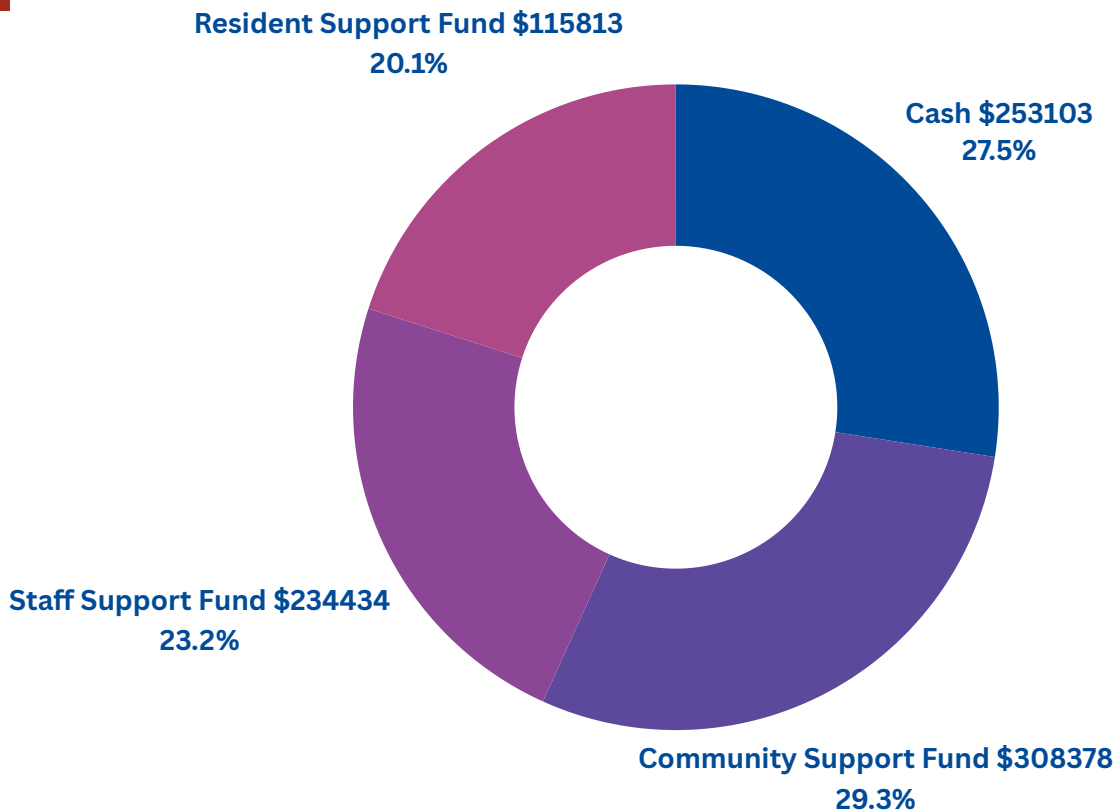
